Training Class Rules and Regulations

You are required to show veterinarian proof of UP TO DATE vaccinations for your dog against Rabies, Distemper, Bortadella and Parvovirus before your dog is allowed in class. Due to limited space please leave young children home.

Dogs must be on a 6ft leash at all times. NO FLEXI LEASH.

Please exercise (allow your dog to relieve itself) before you come to class. Should your dog have an accident in the training room or grounds, it is your responsibility to clean up. By picking up after our dogs, we are allowed to use the facility.

For the safety of all class members, instructors and other dogs, if any dog enrolled in class displays aggression on more than one occasion, the owner may be asked to leave the class without a refund. Suggestions may be made to alternative training facilities

There will be NO REFUND of class fees after the first class. . If we cancel a class due to facility issues or weather, we will make every possible attempt to re-schedule that class.

Junior Handlers under 18 years of age must be accompanied by an adult at all times.

Due to limited space, please leave young children at home; only dogs enrolled are allowed in the building.

Make sure your dog has identification tags on.

You will receive a postcard or e-mail confirming the date and time of your class.
